Financial Plan update (an article from FinPro member, Malcolm Lewis)

It is now only one month to go before we are required to adopt the Financial Plan (due 31 October). As a sector, the financial professionals have again rose to the challenge by adding a further report to what often seems like an ever-increasing list of annual compliance documents.

The Financial Plan template, that FinPro developed on behalf of LGV and the sector, was designed primarily as a compliance document to satisfy the new LG Act and the new Regulations. The legislation also requires each Council to follow their own engagement policy, which often means deliberative engagement prior to final adoption.

This presents its own challenges given the Financial Plan document is prepared in line with accounting and legislative standards rather than in a format that the community can be easily understood by the community. One option to support deliberative engagement is to include the output-based Council Plan format to the Financial Plan. Provided year one of the Financial Plan aligns with the numbers from the adopted Budget this should be achievable without significant rework.

The Council Plan format reports gross expense, income and the net spend for each service that could then be further broken down into the net spend for the average ratepayer or even a net spend for every person in the municipality. This information should enable the community to more readily understand the relative cost of each service that cannot be easily identified from the accounting-based compliance reports.

Given this is only year one, the next stages in the journey will be to provide a more strategic focus and continually develop the integration framework including the linkages to the key documents that underpin the development of the Financial Plan.

Asset Plan

Just to note as an update on an LGV working group meeting about the Asset Plan. FinPro has some representatives getting along to meetings as well, and below are a few points from this meeting last month.

The key item that was confirmed is that deliberative engagement is NOT mandatory for the first Asset Plan cycle. This has been written into a revised tech description – which is available <u>here</u> on the LGV website (scroll down to 6.4 – Asset Plan).

In the first meeting, which was back in August, there were a few questions raised, including:

- Is the output a template or something else? Guidelines? Principles?
- Considered length would a page of principles guiding AM be enough or is something more detailed required?
- How much must it integrate with other plans (Integrated Strategic Planning)? Will there be an audit process to ensure compliance?
- There was discussion about what was 'non-negotiable' and what were nice-to-haves/capability building activities.

Access to funding through TCV - Update

FinPro representatives met with representatives from LGV and TCV yesterday (30 September 2021) to discuss the proposed TCV loan to local government. On behalf of the sector, FinPro has welcomed the initiative from the state government and provided a list of questions that were collected from its members.

The discussion was productive and LGV has undertaken to provide a Q&A based on these questions. Once received we will distribute to members.

We are also keen to hear from Councils who may be seeking to refinance loan maturities occurring prior to January 2022 (ie. existing loans undertaken through the Local Government Funding Vehicle or other banking institutions) or those seeking to undertake new borrowings to identify level of funding demand likely for the sector at this point as we continue our engagement with TCV. If you have any information in this space please <u>contact Gab</u> and she will collate this information which will be valuable in further discussions with LGV / TCV.

Grosvenor Rate Cap Review

FinPro Committee members. Tony Rocca, Binda Gokhale and Danny Wain, attended a consultancy session with Grosvenor yesterday (30 September 2021) regarding the Rate Cap.

The discussion was an opportunity to provide input into how the Rate Cap has operated since its inception. It covered the Policy objectives of the cap, and whether they are being achieved, how well they have or have not been achieved and why. Additionally, it covered elements of the Act and whether there are better ways the cap can be measured and what those elements would be and why.

Thus far, the group at Grosvenor have undertaken six workshops within the sector. There is another workshop on the <u>8 October 2021</u> that is being run for others that may have missed out.

Update from VAGO

The following information was distributed to councils from CAGO on 29 September 2021 and is shared for member information:

Hi all,

I hope you are safe and well.

VAGO performance audit and other integrity bodies — <u>September 2021 update</u> is available now for your reference. The layout is different to previous months as we are using a common template with performance audit.

Cyber-attack alert!

- As many of you are already aware, a <u>Victorian council experienced suspected cyber-attack</u> <u>earlier this month</u>. Google search shows other councils also has been targeted in cyber-attacks in recent years. Refer <u>here</u>, <u>here</u> and <u>here</u> for details.
- Refer to <u>Victorian Government resources</u> to prevent a cyber incident including some basic steps you can take to improve your organisation's cyber security. Refer to <u>cyber security</u> <u>standards and guidelines</u> and <u>Cloud security guidelines</u>.
- Refer also to <u>Federal Government resources</u> on useful advice for improving cyber security. This includes mitigation strategies compiled by The Australian Cyber Security Centre —<u>The Essential Eight maturity model</u> that organisations can use to improve their cyber resilience and <u>cyber security quidelines (ISM)</u> that provide practical guidance on how organisations can protect their systems and information from cyber threats.

Roads to Recovery (R2R) and Local Roads and Community Infrastructure (LRCI) grant acquittals are due by 31 October 2021:

• We will resource up during October 2021 to meet your 2020-21 R2R and LRCI acquittal submission timeline. I am **not** aware of an extension for these grant acquittal deadlines at this stage.

Two-month extension to submit 2020-21 annual report:

- On 15 of September 2021, Acting Minister for Local Government approved a two-month extension to Councils and RLCs to meet their legislative reporting obligations. This means that councils and RLCs have until 30 November 2021 to submit their annual report to the Minister for Local Government.
- I have already informed your auditors on this extension and provided a copy of the formal advice from the Minister for reference.

Update on 2020-21 audit program:

• With 104 local government entities to audit for 2020-21 financial year, we are on track to issue audit opinions for 62 LG entities by cob today. Under the circumstances we all are in, I believe



it is a **very good outcome for the sector!** Based on prior year experience with similar extended reporting timelines, I expect most of the remaining report certifications and audit opinion releases will happen in the next couple of weeks.

• At this stage, I am not aware of any major delays in VAGO audit opinion release process. However, if you have any concerns about the turnaround or timing of VAGO reviews/ opinion issue that are with us currently for clearance, please do reach out asap.

Other matters:

- The 2020-21 LG Parliamentary report is on track for tabling by 30 November 2021. We are reimagining report design to make it more concise and easier to consume.
- AUASB recently <u>released a publication</u> that is focussed on data integrity, addressing matters related to the collection and transformation of data by the auditor. I believe **some of the commercial considerations discussed in this publication will be important to you** in the context of auditors collecting, transforming, and using data as part of audit process.
