Technical Updates

Local Government Act Implementation Update

The new Local Government Act 2020 is the most ambitious reform to the local government sector in over 30 years. The Act will improve local government democracy, accountability, and service delivery for all Victorians.

LGV Bulletin - 33/2022 Council Asset Plan

The following Bulletin (Bulletin: 33/2022) was issued by LGV on Friday 17 June 2022 and is included here for member information:

COUNCIL ASSET PLAN

Councils are required to adopt an Asset Plan by 30 June 2022 in accordance with section 92 of the <u>Local Government Act 2020</u> (the Act).

To help councils prepare their Asset Plan, Local Government Victoria developed the <u>Asset Plan</u> <u>Guidance 2022</u> in collaboration with a working group made up of sector representatives from across local government.

The Asset Plan is crucial in setting the direction and priorities of councils to support and deliver on community expectations and needs.

Deliberative engagement is not required for the first Asset Plan. However, the first Asset Plan must be developed in accordance with council's community engagement policy.

Councils are also reminded that there is no requirement to submit the Asset Plan to the Minister for Local Government. Compliance with section 92 of the Act must be recorded by councils in the governance and management checklist included in their annual report.

The Asset Plan must be made publicly available in line with each council's public transparency policy and the public transparency principles in section 58 of the Act.

The Local Government Amendment (Rating Reform and Other Matters) Bill

This Bill progressed through Parliament on 23 June 2022 with its second reading occurring. Debate on the Bill was adjourned for one week, so will come back to Parliament in a weeks' time.

Rating Best Practice Guide Update

FinPro Executive Committee members, Wei Chen, Binda Gokhale, Fiona Rae and Tony Rocca are part of the Local Government Rating Reform - Sector Working Group. The Working Group comprises members from FinPro, RMA (Revenue Managers Association) and LGV.

We met last week, and discussed key rating topics, such as rating differentials and what guidance may be useful for the sector going forward, given the outcomes of the Rating Review. The group will meet approximately every three weeks, with the next hot topic being that of Hardship.

Post the rating review and ombudsman's report, Finpro worked with the RMA to put some guidance together, however, given the recent Rating Bill being reviewed in Parliament, this sector wide working group will help to determine what this guidance will look like going forward.

We will continue to keep members informed as more information is obtained via the sector working group.

Beneficial Enterprises - s.110 of LGA 2020 - Sector Guidance

LGV has engaged an external consultant, Craig Kenny from Mach 2 Consulting, to help establish some sector guidance or how to consider the application and benefits of utilising the new Section 110 of the Local Government Act 2020.

In that engagement, LGV and Craig have reached out to the FinPro Technical Committee to obtain some views and feedback on what the guidance could look like. The groups met in a hybrid environment on Thursday 22 June 2022 to talk through a discussion paper. Once draft documentation is developed, Finpro will have an opportunity to provide any further input into the process.

We will continue to keep members informed as more information becomes available.

ESC update – Annual compliance information 2022-23 requirements

The following information was distributed to the sector by the ESC on Wednesday 22 June 2022 and is included here for member information:



Dear all

As the end of financial year approaches, we would like to remind councils that the annual compliance submission for 2022-23 is due on 30 September 2022.

Valuations to reflect 30 June and 1 July

As a reminder, rating system reports must include:

- Total valuations as at 30 June 2022 and 1 July 2022 for each differential category
- Number of rateable properties as at 30 June 2022 and 1 July 2022 for each differential category
- <u>Number of municipal charge properties</u> as at 30 June 2022 and 1 July 2022 (if this does not appear on your council's rating system reports, other supporting documentation is acceptable)

For councils that cannot provide rating system reports, the numbers must be reconciled to the Valuer General's report of general valuation.

CEO certification and signed rating system reports

Please ensure that both the CEO certification form and valuation reports are signed by the CEO. Any changes made to the template after it is submitted will require a new certification.

New waste charges in 2022–23

As part of the compliance report we monitor and report on councils that introduce new service charges to ensure that the rate cap is working as intended. If your council is introducing a new service charge in 2022–23, we ask that you provide the following when you submit your compliance information:

- · Information about the council's engagement process and outcomes.
- · Information that shows the revenue impact the new waste charge has on ratepayers.
- · Revised Revenue and Rating Plan.

2022 National General Assembly of Local Government Communique

As discussed briefly in the President's Message, Bradley Thomas attending the 2022 National ALGA Conference in Canberra earlier this week. A summary of the conference was provided by ALGA and is included here for member information.

Local government leaders from around Australia gathered in Canberra from 20 – 22 June 2022 for the 28th National General Assembly of Local Government (NGA).

This event was held on the traditional lands of the Ngunnawal people, and the Assembly paid its respects to their elders past, present and emerging, and acknowledged the vital and ongoing contributions First Nations peoples continue to make to our nation.

Around 1,000 delegates welcomed and congratulated the Albanese Government on being elected and thanked the many federal members of parliament who attended and spoke at the NGA or associated events, including Minister King, Minister McBain, Minister Watt, Minister Burney, Minister Rowland, Leader of the National Party David Littleproud, and Zali Steggall OAM.

All reaffirmed the importance of local government, and councils look forward to seeing action through better partnerships.

Local governments asked for a Minister in Cabinet, and we welcome the appointment of Cabinet Minister King supported by former Bega Valley Shire Mayor Minister McBain.

The Assembly welcomed the announcement from Minister King that she would work with Minister McBain to re-establish the Australian Council of Local Governments and was encouraged by the Government's willingness to engage and partner with local councils.

In keeping with the theme of the Assembly 'Partners in Progress', Councillors committed to partnering with the Australian Government to progress critical reforms, including national productivity, climate change transition, Closing the Gap, housing affordability including increased social housing, appropriate road safety reforms, restoring integrity of federal funding to local government, and improved local delivery of community services.

The Assembly committed to progressing the next step of Closing the Gap and passed a motion supporting the Uluru Statement from the Heart.

The Assembly heard from leading economists that local government is the most productive level of government yet collects just 4% of national taxation revenue. The Assembly agreed that councils need more sustainable and transparent formula-based funding to restore integrity to federal funding of local government.

Further, they noted the essential federal funding support to local communities and called on the Government to review Financial Assistance Grants and restore them to at least 1 percent of Commonwealth taxation revenue.



Delegates and speakers recognised the protracted challenges of the COVID pandemic, unprecedented droughts, bushfires, and recent floods, and commended the work of local councils, local communities and government agencies on their work on emergency response and recovery.

A number of flood affected leaders also met personally with the Prime Minister, and highlighted ways to better work together to prevent and prepare for natural disasters.

The Assembly warmly received Governor-General David Hurley and his comments on the vital role councils are playing supporting disaster impacted communities and will need to play in the future.

The Assembly noted however that more needs to be done on mitigation and the prevention of climate induced natural disasters.

The Assembly discussed the global challenges to democracy and the critical importance of local government. The Assembly reaffirmed its commitment to strong local leadership, transparency and public accountability, free and fair elections and local democracy.

After a stirring address from the Ukraine Ambassador, the Assembly passed a unanimous motion supporting the Ukraine people and their legitimate and democratically elected governments.

Other critical issues addressed at the Assembly included migration between cities and regions, housing affordability and the role councils can play in social housing in particular, critical workforce challenges and road safety.

Delegates agreed to continue to meet with their local federal members to highlight the importance of sustainable and transparent funding for local governments, and better partnerships that will help support progress in every community.

Convened by the Australian Local Government Association (ALGA) the NGA is the largest national gathering of democratically elected representatives in the nation. ALGA is the national voice of local government and will review more than 106 policy initiatives adopted by resolution of the Assembly in the coming months.
