

#### Observations in relation to PIPE



#### **Fixed asset registers**

- not reconciled with GL
- maintained in multiple spreadsheets



#### **Work-in-progress**

- contain negative balances
- not reconciled with GL
- contain projects with no charging



#### **Depreciation**

- understated due to delay in capitalisation date
- not captured for monthly/quarterly management accounts

#### **Valuation**

- audit adjustments








