# **State and Federal Inquiries**

The State and Federal Parliament reviews into LG sustainability continue.

The State inquiry held their last hearing on Tuesday 8 October in Melbourne. The report is due to table its report in Parliament on 28 November 2024.

The Federal inquiry held their last hearing in Canberra on 10 October 2024.

We look forward to these inquiries being finalised in coming months, and the release of meaningful recommendations.

# VLGGC – 2024 Annual Allocation Report and Submissions

The following information was distributed to councils on 15 October and is shared here for member information.

#### Annual Allocations Report

I am pleased to advise that the Victorian Local Government Grants Commission's Annual Allocation Report for the year to 31 August 2024 has now been tabled in the Victorian Parliament.

The Annual Allocation Report contains information on the Commission's activities for the year and details of how each council's general purpose and local roads grants for 2024-25 have been calculated.

#### Submissions to the Commission

I would also like to take this opportunity to remind councils that written submissions in relation to the allocation of the financial assistance grants for 2025-26 should be lodged no later than 28 February 2025.

The Commission would appreciate receiving input through submissions from councils, including in relation to the overall set of cost adjustors to be used, the cost adjustors and cost drivers to be applied to each expenditure function, and the weightings applied to each cost adjustor.



It should be noted that the case for changing the application of particular factors in the methodology is strengthened if councils are able to provide empirical data, demonstrating the impact of these factors on cost levels or the demand for services.

To assist you in preparing submissions you may wish to refer to your council's Individual Report that was sent in late August detailing the 2024-25 allocation. Further information about the cost adjustors and other aspects of the allocation methodology can be found in the Commission's Annual Allocation Report on the website. Also, the Commission will list or publish the submissions received on the website.

# LGV Update – Bulletin 20/2024

The following information was distributed to councils on 25 October 2024 and is shared here for member information.

### LOCAL GOVERNMENT (GOVERNANCE AND INTEGRITY) AMENDMENT REGULATIONS 2024

The Local Government Amendment (Governance and Integrity) Act 2024 was recently enacted, making various amendments to the Local Government Act 2020 (the Act) to enhance standards of governance and behaviour across the local government sector (see Bulletin 10/2024).

The Local Government (Governance and Integrity) Amendment Regulations 2024 (the Amending Regulations), which amend the Local Government (Governance and Integrity) <u>Regulations 2020</u> (the Regulations), were made on 22 October 2024 to implement these reforms. These changes will come into effect on **26 October 2024**.

The Amending Regulations:

- Update the subjects to be addressed in Councillor induction training
- Prescribe the subjects which must be addressed in the mandatory Councillor induction training, Mayoral training and annual Councillor professional development
- Set the date by which the Councillor professional development training must be completed annually by Councillors
- Replace the current Standards of Conduct for Councillors with the mandatory new Model Code of Conduct



- Prescribe the new Internal Resolution Procedure to be implemented by Councils for dealing with alleged breaches of the Model Code of Conduct (Note Councils will have until 1 July 2025 to develop and adopt the new Internal Resolution Procedure)
- Make other minor and technical amendments to the regulations to support these reforms (e.g. require an application specify any steps taken by the Council to resolve the matter, and if the Council did not take any steps, the reason why the Council did not do so).

These changes to the Act and Regulations have been developed in response to governance issues and recommendations identified in recent governance interventions and integrity body reports. This includes acquitting six recommendations in the Independent Broad-based Anti-corruption Commission's Operation Sandon Special Report relating to establishment of a Model Code of Conduct (Recommendations 17, 21 and 31) and ongoing professional development training (Recommendations 18, 20 and 28).

Local Government Victoria consulted extensively with the local government sector and community in developing the mandatory training, Model Code of Conduct and Internal Resolution Procedures, and the associated guidelines. There was valuable input and overall a strong level of support from the submissions received. #### **Implementation**

Guidance materials to support councils and councillors understand and comply with the new requirements in relation to the Mayoral and Councillor mandatory training and Model Code of Conduct are being developed and will be made available shortly at: <u>Guidance Materials</u>.

Councils will have until 1 July 2025 to develop and adopt the new Internal Resolution Procedure. In the interim, councils may continue to apply any existing internal processes previously adopted by the council (for example, any processes incorporated in the council's previous Councillor Code of Conduct).

*Further, please note that as outlined in the Consultation report, the Amending Regulations will no longer require councils to adopt a social media or confidential information policy.* 

Councils may still wish to adopt any policy, protocol or procedure they consider appropriate in relation to good governance and are encouraged to do so where appropriate to guide councillors in meeting the standards of conduct set out in the Model Code of Conduct.

We encourage councils to review the rates currently paid on their at-call accounts with their transactional bank and consider this facility to maximise returns on any surplus cash balances.
