David leads the organisations work in developing and delivering mitigation and adaptation projects, advocating on behalf of members, supporting information sharing and networking and overseeing a research program. He has previously worked as a sustainability behaviour change consultant in the UK and Australia, and currently teaches climate change responses as a Masters course at RMIT University.



Charlotte Turner is an Associate in Minter Ellison's Climate Risk Governance Team, focusing on change risks (and opportunities) through a financial, corporate governance and liability lens. Charlotte is also experienced in a range of litigation matters including class actions and has recent Royal Commission experience. Charlotte is currently studying for a masters in environmental science at Melbourne.



Jessica Christiansen-Franks is an urban designer and social entrepreneur who has dedicated her career to understanding the social dynamics of urbanisation. Passionate about creating neighbourhoods people love and feel connected to, Jessica is a thought leader in innovative citizen participation, and particularly the value of 'placemaking' as a tool for collaboration and inspiring active citizenship. With experience across Australia, as well as the UK, Canada, India, Vietnam and the Philippines, Jessica has been fortunate enough to advise the public and private sectors, along with major international aid agencies.

As Co-founder and CEO of Neighbourlytics, Jessica has side stepped into the world of big data to develop a social analytics platform for neighbourhood development. Neighbourlytics harnesses social data feeds to provide real time insights into local neighbourhood identity, place attachment and social connectedness.

A champion for the citizen voice, Jessica is Vice Chair of the Smart Cities Council's (AusNZ) Centre for Civic Innovation.



Justin Hanney started in the role of CEO of the City of Melbourne in January 2019. Prior to this, Justin worked as the Head of the Employment, Investment and Trade Group within the Department of Economic Development, Jobs, Transport and Resources.

His portfolio encompassed economy-wide work to attract and facilitate international and domestic investment,

grow employment and expand Victoria's offshore trade. Justin had responsibility for development of Victoria's key sectors and oversight of key entities as well as the delivery of Victorian Government nominated major projects.

Justin was previously CEO at the City of Yarra and the City of Wangaratta. As City of Melbourne CEO, Justin has made it his priority that Melbourne continues to be a leading organisation for a leading city for all people, whether they come here to live, work or visit.

CLARENDON AUDITORIUM – Venue for FinPro Seminar, 21 February 2020

Venue Details:

Clarendon Auditorium

The Clarendon Auditorium is within the Melbourne Convention & Exhibition Centre (MCEC) – The room we are using for our event is at the Clarendon Street (Spencer Street) end of the complex.

There will be signage for the room and also, there will be some of the FinPro Executive, wearing black FinPro polo shirts, in the foyer to help guide you to the room.

Getting there:

BY FOOT: Enjoy the walk along the Yarra River and enter the Centre at Spencer Street.

BY TRAM: Tram routes 96, 109 and 12 (Stop 124A Casino/MCEC) will all take you to our Clarendon Street entrance. Otherwise, tram routes 70, 75 and the City Circle (Stop D5) take you to Flinders Street. From there, it's just a short walk up Clarendon Street until you reach us. For tram timetables or further trip planning, use Public Transport Victoria's Journey Planner.

BY TRAIN: The closest station is Southern Cross. Once you exit the station, you can catch the 96, 109 or 12 tram routes and arrive at MCEC in just a few stops. For train timetables or further trip planning, use Public Transport Victoria's Journey Planner.

BY CAR: If you're being dropped off at the Exhibition Centre, our Clarendon Street entrance is the closest entrance.

BY CAR: If you're driving in, the Exhibition Centre car park can be accessed via Normanby Road. Parking details – best to book online **in advance** as you can get a full day carparking for as little as \$15 (follow the car parking link on [this page](#)) When parking under the Exhibition Centre the entrance is located on Normandy road. Once inside the carpark the closest gate to the **Clarendon Auditorium is Gate 1 or 2**. Once parked, please proceed up the stairs and turn right until you are at customer service desk – than proceed up the stairs and it is the first room.

BY TAXI OR UBER: If you're heading to the Exhibition Centre, ask your taxi or Uber driver to drop you off at MCEC's Clarendon Street entrance.



The FinPro seminar will be in the Clarendon Auditorium, which is located at the Clarendon Street end of the Exhibition Centre (Jeff's Shed).

A few notes about the day

Morning tea will be provided between 9.15 and 10am.
