For over twenty years Victorian councils have been selling and educating the virtues of recycling and since China made the decision to clean up its own backyard and deny western countries access to be the world's dumping ground for recyclables, we have come to the realisation that recycling isn't what we thought it was!! Every council has been forced to confront the reality that we don't have much home-grown recycling capability and as world markets are closing their borders, we need some solutions fast!!

Our experts today will hopefully shed some light at the end of the recycling tunnel and hopefully it's not a waste truck heading to landfill coming the other way. Paul Clapham, Director, Procurement and Contracts, Metropolitan Waste and Resource Recovery Group (MWRRG) – will provide a snapshot of where we are headed with Victorian wide solutions on recycling contracts, waste to energy initiatives and the government's plans & responses to the crisis. George Hatzimanolis is the CEO of Re-Purpose and is the leader of a company at the forefront of recycling innovations that might just turn the tide on recycling, waste and landfill. #### **Venue Details:**

#### **Clarendon Auditorium**

The Clarendon Auditorium is within the Melbourne Convention & Exhibition Centre (MCEC) – The room we are using for our event is at the Clarendon Street (Spencer Street) end of the complex.

There will be signage for the room and also, there will be some of the FinPro Executive, wearing black FinPro polo shirts, in the foyer to help guide you to the room.

#### **Getting there:**

BY FOOT: Enjoy the walk along the Yarra River and enter the Centre at Spencer Street.


**BY TRAM:** Tram routes 96, 109 and 12 (Stop 124A Casino/MCEC) will all take you to our Clarendon Street entrance. Otherwise, tram routes 70, 75 and the City Circle (Stop D5) take you to Flinders Street. From there, it's just a short walk up Clarendon Street until you reach us. For tram timetables or further trip planning, use Public Transport Victoria's Journey Planner.

**BY TRAIN**: The closest station is Southern Cross. Once you exit the station, you can catch the 96, 109 or 12 tram routes and arrive at MCEC in just a few stops. For train timetables or further trip planning, use Public Transport Victoria's Journey Planner.

BY CAR: If you're being dropped off at the Exhibition Centre, our Clarendon Street entrance is the closest entrance.

BY CAR: If you're driving in, the Exhibition Centre car park can be accessed via Normanby Road. Parking details – best to book online <u>in advance</u> as you can get a full day carparking for as little as \$15 (follow the car parking link on <u>this page</u>) When parking under the Exhibition Centre the entrance is located on Normandy road. Once inside the carpark the closest gate to the **Clarendon Auditorium is Gate 1 or 2.** Once parked, please proceed up the stairs and turn right until you are at customer service desk – than proceed up the stairs and it is the first room.

**BY TAXI OR UBER:** If you're heading to the Exhibition Centre, ask your taxi or Uber driver to drop you off at MCEC's Clarendon Street entrance.



The FinPro seminar will be in the Clarendon Auditorium, which is located at the Clarendon Street end of the Exhibition Centre (Jeff's Shed).
