## Local government

### 2024-25 financial reporting cycle



AASB 13 *Fair Value Measurement* has been amended.

The amendments are applicable for the 2024-25 financial year for agencies with a 30 June balance date.

Amendments include authoritative implementation guidance to be followed by not-for-profit public sector entities when measuring their non-financial assets not held primarily for their ability to generate cash inflows at fair value.

Key amendments include:

- assessing highest and best use of assets
- developing unobservable inputs and
- application of the cost approach to fair value.

Finance teams and their Audit and Risk Committee should familiarise themselves with the amendments. We encourage finance teams to prepare a briefing paper and hold discussions with their valuer early in the piece.

A FINPRO working group is working towards releasing some guidance material, with worked examples, to the sector during February 2025.

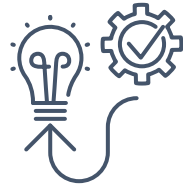

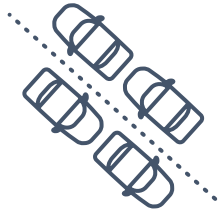

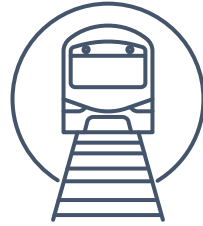
